Important Note: The voided check for the bank account must match record title, which is the legal name on your real property deed, recorded in the County Clerk and Recorder's Office, where the property is located. If these do not match with your application, it will not be processed.

Examples:

- If record title is held in a business, corporation, LLC, or partnership, the voided check will match the business, corporation, LLC, or partnership, and signors need to match those that have been provided on the Statement of Authority.
